


Association Registration & Taxation


This association has been registered with registration No.208/2008 at Hyderabad, India

The association has also obtained income tax exemption under section 80(g) for life time due to which the donor will get tax exemption as per rules in vogue in India. [orders issued by director of income tax (exemptions) Hyderabad, India f.No.Dit(e)/80g/94(03)/10-11 dated July 25, 2011]

Similarly, this association has obtained income tax certificates under 12a which exempts the association to pay the tax on the donations realized by the association. [orders issued by director of income tax (exemptions) Hyderabad, India proceedings no. Dit(e)/12a&80g/02(07)/09-10 dated August 12, 2009]

Construction of Hostel

Construction of hostel for the poor and needy students in Kammaguda (Near B.N.Reddy Colony) – Hyderabad city, India which provides the children an amicable atmosphere to study effectively and better their future. We can find the route map and proposed structure here.





Proposed Hostel Building

After making a thorough search for the proper location a convenient place for proposed construction a land admeasuring 875 sq. Yards is identified and purchased and got registered in the office of the sub-registrar, Vanasthalipuram, Hyderabad, vide document no.635 on February 13, 2014 India at a cost of INR 35 lakhs.



Proposed Hostel permissions

Foundation stone was laid on 2nd March, 2014, which was attended by many prominent and eminent people from various walks of life.

Required permissions from gram panchayat for construction of Ground plus Two floors has been obtained to start the work with letter no.31/2014 dated May 26, 2014.

An agreement with the contractor has been entered into on August 01, 2014 for construction of ground floor in the initial stage at a cost of INR 75 lakhs



Proposed Hostel Present Target


Construction work for the Ground floor only, whereas the design of steel structure is made for construction of Ground plus Five floors

Construction of rest of floors will be taken up during the course of time based on the receipt of funds through donations from **Generous Donors**

- 1. 13 Feb' 2014 Site Land purchased & registered
- 2. 02 Mar' 2014 Bhoomi Pooja performed
- 3. 09 Mar' 2014 Borewell has been laid
- 4. 26 May 2014 Construction permissions acquired
- 5. 01 Aug' 2014 Construction commenced
- 6. 15 Sep' 2014 Construction upto plinth level
- 7. Construction is in progress

Out of 875 Sq. Yds., the proposed built-up area is 700 Sq.yds. (About 6,300 Sq. Ft.)

Excavation work with the foundation for G+5 Floors has been completed.

Required steel for the above work has been obtained.
